AMENDMENT NO. 2 INTERSTATE AGREEMENT

Funding Agreement for the Columbia River Crossing Project Washington State Department of Transportation Oregon Department of Transportation

THIS AGREEMENT AMENDMENT NO. 2 is between the STATE OF WASHINGTON, Department of Transportation, acting by and through the Secretary of Transportation, hereinafter the "WSDOT" and the State of Oregon, Department of Transportation, acting by and through the Oregon Transportation Commission, hereinafter the "ODOT," together referred to as "PARTIES," and individually, the "PARTY."

RECITALS

WHEREAS, WSDOT is authorized by the Revised Code of Washington (RCW) 47.52.020, RCW 47.04.080 and RCW 39.34.030 to enter into this AMENDMENT NO. 2, and ODOT is authorized by Oregon Revised Statues (ORS 190.410 to 190.440 and ORS 381.005 to 381.820) to enter into this AMENDMENT NO. 2; and

WHEREAS, the PARTIES hereto entered into the original AGREEMENT WSDOT No. GCA 4723 and ODOT No. 22946 on January 3, 2006, and AMENDMENT NO.1 on April 14, 2008, which provided for ODOT and WSDOT to jointly be responsible for the cost of the Columbia River Crossing Project, and

WHEREAS, it is deemed desirable to amend the original AGREEMENT, in accordance with Subsection 1.1 of the original AGREEMENT, to update each PARTIES funding and expenses shown in Exhibit A of the original AGREEMENT.

NOW THEREFORE, in consideration of the terms, covenants, conditions, and performances contained herein, or attached and incorporated and made a part hereof.

IT IS MUTUALLY AGREED AS FOLLOWS:

Exhibit A of the original AGREEMENT and Exhibit A-1 of AMENDMENT NO. 1 is hereby superseded and replaced by Exhibit A-2, attached hereto and by this reference made a part hereof.

All other terms and conditions of the original AGREEMENT shall remain in full force and effect except as modified by this AMENDMENT NO. 2.

IN WITNESS WHEREOF, the parties hereto have executed this AMEMDMENT NO. 2 as of the day and year last signed below.

The Oregon Transportation Commission on June 18, 2003, approved Delegation Order No. 2, which authorizes the Director to approve and execute agreements for day-to-day operations. Day-to-day operations include those activities required to implement the biennial budget approved by the Legislature, including activities to execute a project in the Statewide Transportation Improvement Program.

On September 15, 2006, the Director of the Oregon Department of Transportation approved Subdelegation Order No. 2, Paragraph 1, in which authority is delegated to the Deputy Director, Highways; to approve and sign agreements over \$75,000 when the work is related to a project included in the Statewide Transportation Improvement Program or in other system plans approved by the Oregon Transportation Commission such as the Traffic Safety Performance Plan, or in a line item in the biennial budget approved by the Director.
